#### **ABOUT SOCIETY:**

Shailendra Education Society was established on 31<sup>st</sup> March, 1976. It is registered under the Society Registration Act and also under the Public Trust Act at Dahisar – an extreme suburb of Mumbai. This Society was formed by a group of 125 common citizens who were in government service. The Society believes in holistic development of the students to brace them to face the challenges of competitive world.

A Kindergarten class with 41 students in a small residential flat provided by one of the life members was the beginning of an inspiring intellectual journey.

During the span of 49 years of its journey, the Society has developed an educational complex covering from K.G. class to Secondary School in three mediums, viz. Marathi, Gujarati and English, a Junior College of Arts, Commerce & Science, and a Degree College of Arts, Commerce & Science with full fledged courses like B. Com, B.A., B. Com. (Banking & Insurance), B.M.S., BAF, B.Sc. (I.T.), M.Com (Advanced Accountacy) & M.Sc. (IT) which are affiliated to the University of Mumbai. The Society has a Ph.D. Research Centre under the Degree College in the subject of Business Economics and Commerce under Commerce Faculty. It gives an impetus to research for scholars in the region. The College also centre of Distance Education, University of Mumbai for PCP lectures. For developing different skills among students college started different Value Added courses.

The foundation stone of the educational complex was laid by an eminent educationist late Prof. Shri Ram Joshi, the then Vice – Chancellor of University of Mumbai. The Society has built up 48,000 sq. ft. educational complex with 41 well – lit and ventilated Classrooms, four Laboratories, Teacher Rooms, spacious and well – ventilated Library, four Air Conditioned Computer Laboratories, Assembly Hall, Multimedia Centre, a Rifle Shooting Range, a Gymnasium, Gymkhana, Canteen, Centre for Competitive Exams, a Public Library, a Butterfly Garden, Vermi compost pits and a big playground acquired from MHADA on lease for sports activities.

The Society has also started expanding its activities by purchasing a plot at Kaman in Vasai which is used for camping activities. The Society also has Hi-Tech library in Ashokvan, Dahisar (E), Mumbai. It has also launched an Advanced Computer Laboratory. The Society has a separate Computer Centre "SESCOM", offering various courses affiliated to M.K.C.L.

#### **ABOUT COLLEGE**

The Degree College was started in September 1994 to cater to the long – felt need of the student population of Dahisar, after obtaining permission from the Government of Maharashtra and the University of Mumbai.

The College made a beginning with one division of First Year B.Com class for the academic year 1994–95. The Second year B.Com came into existence from June 1995 by way of natural growth and the T.Y.B.Com. class started from June 1996. The first year B.A. started in 1995-96. The division of First Year B.B.I was started in 2004-05 followed by B.M.S. in 2008-09 and B.Sc. (I.T.) in 2010-11. B.A.F. in 2021-22 M.Com (Advance Accountancy) & M.Sc (I.T.). We have now a full-fledged Degree College in the Commerce and the Arts Faculty. The Arts & Commerce faculties are on 100% grant basis and the College has acquired permanent affiliation status and recognition under 2(f) and 12 (B) of UGC. All the Professors in Arts & Commerce faculties are fully qualified and well experienced. Our result have always been encouraging and higher than the University percentage.

The college has full-fledged courses in B.B.I., B.M.S., B.Sc,(IT), B.Com (A&F), M.Com (Advanced Acoountancy) MSC.(IT) affiliated to University of Mumbai. College has started Research Centre for Ph.D. in the subject at Business Economic & Business Policy & Administrate. The College has successfully completed third cycle of NAAC with B++ grade CGPA score 2.98. College has started Add on Courses.



## **ELIGIBILITY FOR ADMISSION TO B.Com. & B.A. Degree Courses:**

1. A student who has passed the Higher Secondary Examination conducted by the Maharashtra State Board of Secondary and Higher Secondary Education, Pune or an examination recognized equivalent thereto in Arts, Science or Commerce stream, will be eligible for admission to the F.Y.B.A. Class.

A candidate for being eligible for the admission to the three year integrated course leading to the degree of Bachelor of Arts must have passed the Higher Secondary School Certificate (Std. XII) examination conducted by the different Divisional Boards of the Maharashtra State Board of Secondary and Higher Secondary Education with the following subjects:

- i) English.
- ii) Any one of the Modern Indian Language or Modern Foreign languages or any Classical Languages.
- iii) Any four subjects carrying 100 marks each.

#### OR

Must have passed the Higher Secondary School Certificate (Std. XII) examination with Vocational subjects conducted by the different Divisional Boards of the Maharashtra State Board of Secondary and Higher Secondary Education with the following subjects:

- i) English.
- ii) Any one Vocational subject carrying 200 marks prescribed by the Board from time to time.
- iii) Any three subjects carrying 100 marks each.

#### OR

Must have passed the Higher Secondary School Certificate (Std. XII) examination with the minimum competency based Vocational courses conducted by the different Divisional Board of the Maharashtra State Board of Secondary and Higher Secondary Education with the following subjects:

- i) English.
- ii) Any one of the Modern Indian Languages or Modern Foreign languages or Classical Languages.
- iii) General Foundation Course.
- iv) Any one subject carrying 300 marks from among the minimum competency based Vocational courses prescribed by the Higher Secondary School Certificate Examination from time to time.

#### OR

Must have passed an examination of another University or Body recognized as equivalent thereto.

2. As per the University of Mumbai ordinance 2152 of eligibility criteria for admission to F.Y.B.Com: 0.2512

A candidate for being eligible for admission to the three year degree course leading to the Bachelor of Commerce must have passed the Higher Secondary School Certificate (Std. XII) Examination conducted by the different Divisional Boards of the Maharashtra State Board of Secondary and Higher Secondary Education.

#### OR

Must have passed the Higher Secondary School Certificate (Std. XII) Examination with vocational subjects/minimum competency based vocational course conducted by the different Divisional Boards of the Maharashtra State Board of Secondary and Higher Secondary Education.

#### OR

Must have passed an Examination of another University or Body recognized as Equivalent to Higher Secondary School Certificate (Std. XII) Examination.



- 3. A student who has passed the F.Y.B.A. / F.Y.B.Com examination will be eligible for the admission to the Second year course of the respective degree and a student who has passed the S.Y.B.A or the S.Y.B.Com examination will be eligible for admission to the Third year course for the respective degree.
- 4. Students hailing from states other than Maharashtra seeking admission for F.Y / S.Y. /T.Y. classes will be given provisional admission. Their admission will be confirmed only after obtaining the verification report of their mark list from the concerned Board / University. The students will not be issued mark list, leaving certificate, passing certificate or any other certificate till verification report is obtained.

Following are the documents required to be submitted along with for confirmation of admission.

- 1. Original H.S.C. Marksheet and Original Leaving Certificate and five Xerox Copies of both.
- 2. S. S. C. Marksheet and original (for verification) and Two Xerox Copies.
- 3. If claiming admission under reservation documents required are
  - a) Copy of Valid Caste Certificate
  - b) Copy of Ration Card
  - c) Copy of Aadhar Card
  - d) Income Certificate of Parents (Certificate of Tashildar's office or Form No. 16)

The learners to pass a course shall have to obtain a minimum of 40 marks in aggregate for each course. Where the course consists of Internal Assessment & Semester End Examination, the learners shall obtain minimum of 40% marks (i.e. 10 out of 25) in the Internal Assessment and 40% marks in the Semester End Examination (i.e. 30 out of 75) separately to pass the course and minimum of Grade D in each project wherever applicable to pass a particular semester. A learner will be said to have passed the course if the learner passes the Internal Assessment & Semester End Examination together.

## R.8438 Allowed To Keep Terms (ATKT): (Applicable to the courses under faculty of Arts & faculty of Commerce)

Eligibility for Admission to all the Under Graduate Programmes (aided and non-aided) in the Faculties of Arts and Commerce under Credit Based Semester and Grading System:

- a. A learner shall be allowed to keep terms for Semester II irrespective of the number of courses of failure in the Semester I.
- b. A learner shall be allowed to keep term for Semester III if he/she passes each of the Semester I and Semester II

OR

A learner fails in not more than four courses of Semester I and Semester II taken together with not more than TWO courses at each of Semester I & Semester II.

- c. A learner shall be allowed to keep terms for Semester IV irrespective of the number of courses of failure in Semester III.
- d. Eligibility criteria for a learner, to be admitted in Semester V (Third year) of UG programmes (aided and non-aided) in Faculties of Arts and Commerce is amended as follows.
- i) Shall have passed Semester I, II, III and IV in full

OR

ii) Shall have passed Semester I and II in full and secured ATKT in the Second year by failing in not more than Two Courses in each of Semester III and Semester IV

iii) Shall have secured ATKT in First Year by failing in not more than Two Courses in each of Semester I and Semester II and have passed Semester III and Semester IV in full.

e. A learner shall be allowed to keep terms for Semester VI irrespective of grades obtained in each course of Semester V. The result of Semester VI shall be kept in abeyance until the learner passes each of Semester I, Semester II, Semester IV and Semester V in full.

#### ATKT for Faculty of Science is read as under:-

- i) A learner shall be allowed to keep term for Semester II irrespective of grades obtained in each course of Semester I.
- ii) A learner shall be allowed to keep term for Semester III if he/she passes (grade 'D' or above in each course) each of Semester I and Semester II.

OR

He/she fails in not more than three-courses, in each of Semester-I and Semester II (For all Science Programmes, carrying total 900 or more marks.)

He/she fails in not more than three courses with not more than total 200 marks, in each of Semester I and semester II. (for all Science Programmes, carrying less than total 900 marks.)

- iii) A learner shall be allowed to keep term for Semester IV irrespective of grades obtained in each course of Semester III. However learner has to pass either of Semester I or Semester II in order to appear for Semester IV:
- iv) A learner shall be allowed to keep term, for Semester V if he/she passes Semester I, Semester II, Semester III and Semester IV.

OR

He/she has passed Semester I and Semester II and fails in not more than three courses in each of Semester III and Semester IV.- (For all Science Programmes, carrying total 900 or more marks).

He/she has passed Semester I and Semester II and fails in not more than three courses with not more than total, 200 marks in each of Semester III and Semester IV. (for all Science Programmes, carrying less than total 900 marks.)

- v) A learner shall .be allowed to keep terms for Semester VI irrespective of grades obtained in each course of Semester V.
- vi) The result of Semester VI shall be kept. in abeyance until the learner passes each of Semester I, Semester II, Semester IV and Semester V.

## **ATTENDANCE REQUIREMENT:**

**0.119** The following shall be the minimum attendance necessary for keeping terms:

"Three fourths of the days on which the lectures and practicals / tutorials are conducted during the first term and the second term separately".

**N.B.** A day's attendance means attendance at all the lectures, tutorials, seminars and practicals according to the class time table for the day and not at any one of them.

As per University circular no. UG/235 of 1998 for granting the term, minimum attendance of 75% of the theory lectures, practical's and tutorials (wherever prescribed) separately will be required, out of the total number of lectures, practical's and tutorials conducted in the term.

In order to keep the students aware of their attendance, list of defaulter students for each month is displayed on the Notice Board at the end of the month / first week of succeeding month and the signatures of the students are taken on the same. Students whose name appears in the defaulters list for more than two times will not be allowed to appear for the Examinations.



## **RULES OF ADMISSION:**

Admission to the F.Y.B.A/ B.Com, B&I/B.M.S./B.Sc(I.T)/B.A.F. classes will start after declaration of the H.S.C Examination results. Admission to the other two classes will start after the declaration of the result of the respective qualifying examination.

- 1. Students seeking admission should apply in person during the hours notified for the purpose.
- 2. A student will be required to present himself along with an application in the prescribed form duly filled and signed by him/her and his/her parents/guardians.
- 3. Parents are requested to accompany the ward at the time of admission.
- 4. No admission shall be regarded as duly granted unless it is granted by the authority or the Principal and the necessary fees received by the College.
- 5. All admissions are valid only for one academic year and are required to be renewed by an application in the prescribed form for every subsequent year of study in this college.
- 6. Normally a student of this college who has qualified himself for admission to the higher class, will be admitted to such a class provided an application for the purpose in the prescribed form, duly filled in has been received with the necessary fees within the notified period.
- 7. Once a student is admitted to the college he shall be liable to pay the full fees for the whole year.
- 8. For securing admission to any class, it is necessary to produce in original:
  - \* The passing certificate of the last examination passed
  - \* Statement of marks
  - \* "No Objection Certificate" from the Head of the Institution of the college last attended in the case of student coming from the other colleges and joining the S.Y/T.Y.
  - \* Transfer Certificate in the case of students coming from the colleges affiliated to the University of Mumbai.
  - \* Eligibility Certificate in the case of students passing an examination other than the H.S.C examination of the Maharashtra State Board of Secondary and Higher Secondary Education, Pune or Examination of any University other than the University of Mumbai as the case may be.
- 9. All admissions are provisional until Enrolment Certificate / Final Eligibility Certificate / Transfer Certificate, (if necessary) is submitted to the college.

## FEE STRUCTURE (Note):

- 1. All students are required to pay the annual fees at the beginning of the year.
- 2. Foreign Student Tuition fees will be Rs. 4000 per annum. Other fees will remain the same.
- 3. As Per University of Mumbai Norms, in case of any increase in the fees, the students will be required to pay the difference
- 4. Document verification fees & Provisional Eligibility Certificate fees of Rs.1500/- to be charged from the students those who are not from Board of Higher Secondary Education in Maharashtra.

## FACILITIES

## **COLLEGE LIBRARY:**

Library is the heart of every Institution. Shailendra College Library always aims to achieve reader's satisfaction. In has a rich collection of nearly 47934 books covering wide aspects of knowledge. In the beginnings of the first term, two library cards, one for borrowing academic books and the other one for non-academic books & journals, will be issued to all the students. Library had purchased two kindly readers to read - e - books.

Student can borrow a textbook and non-academic book or journal for seven days. Student are provided free internet surfing facility in the library. Library has inter - library linkages with neighboring College Libraries.





The library remains open for study, reference and issue of books from 8.00 a.m to 6.00 p.m.. on all working days. Even the ex-students can avail the library facility.

With the implementation of the Library Software SOUL, our Library is fully computerized with Bar Code System. Library subscribed to "National Library and Information Services Content (N-List) project of INFLIBNET. It provides access to 6,000 e-journals and 1,99,500 e-books through N-List and 6,00,000 e-books through National Digital Library to students, researchers and faculty members.

## **COLLEGE BOOK BANK:**

The college has a Book Bank facility which is provided to the economically weak students. The Book Bank comprises of 2392 books. The collection of books is increasing over a period of time with generous contribution from the staff members & students. We also offer Book Bank facility to Banking & Insurance, B.M.S., B.Sc.(IT) and B.A.F. students. From UGC, Development Assistance grant, books were purchased for College Book Scheme.

#### **B.C. BOOK BANK:**

College is also offering Book Bank facility to reserved category students with the help of financial assistance from the University of Mumbai. It has collection of 3557 books.



## **COMPUTER LABS:**

The College has fulfilled its vision of full computerization. We have established five computer lab. Computers in all these five labs are in LAN. We have in all 127 computers. All these labs are fully airconditioned and are well-equipped with Wi-Fi facility. Battery backup (UPS), LCD projector, high speed server computer, latest updated software and latest windows programme in all computers.

We also have a 5kg fire extinguisher and a web camera for security purpose in Demonstration. Labs are available to the students for preparing projects, presentation, internet surfing etc.



#### **ELECTRONICS LAB:**



Taking into consideration the need for B.Sc. (I.T) students the college has set up a separate Electronics Lab with all the necessary equipments for electronics practicals.

The internal working of computers is based on Electronic concepts. Students actually get first-hand experience in handling computer hardware in this lab.

In the year 2011 with the help of UGC grant under the category 'Innovative Methods in Teaching', a work shed of 130 sqft with 6 composting pits of  $3 \times 7$  sqft was made. Since then every year dry leaves in the campus and organic waste generated in the canteen were recycled into valuable compost. More than 1000 kg of vermicompost was harvested every year. The compost was used in gardens in the campus and municipal area outside the campus.

We have also set up a campus habitat for butterflies, "Butterfly Garden" since 2011 wherein host and nectar yielding plants are planted to attract our winged visitors. Butterflies are valuable indicators of ecological health and are essential pollinators that ensure the propagation of plant species.

#### **CAREER GUIDANCE AND PLACEMENT CELL:**

Various programmes like Freshers Party, Annual Day, Annual Sports Day, Degree Distribution Ceremony, Teachers Day Funfair, celebration of various days Aroma, Shailendra Chashak etc, are independently handled by them. They get an opportunity to display their qualities of leadership, coordination, hard work, perseverance and organizing skills and it goes a long way in the development of their personality and installs in them a sense of unity and discipline which facilitates them to become better human beings of tomorrow.



#### **COLLEGE RULES & REGULATIONS:**

- 01. Every student shall obtain, on admission, his identity card. The students shall always carry the card with his photograph affixed thereon and attested, and shall present it for inspection as and when demanded. No student will be allowed to attend the classes, tutorials etc. unless he has an attested identity card with him. The procedure for obtaining the identity card will be put up on the notice board.
- 02. Students shall attend lectures, tutorials and seminars according to the Time Table on all working days of the College. Students shall not remain absent during Lectures, Tutorials, Seminars and examination without the prior permission of the Principal. Absence without prior leave may lead to loss of term. As to keep a term, a student has to complete to the satisfaction of the Principal, the course of study prescribed for the class to which he belongs. In case of default in attendance, students are warned that, their names will not be kept on the college rolls with effect from the beginning of the Second Term of the academic year.
- 03. In case of illness, a student shall apply for leave by post as soon as possible with a doctor's certificate attached to the application and shall report to the Principal immediately after resuming attendance.
- 04. In case if the student remains absent even for a lecture, the student is required to submit a leave note duly signed by the parents and report the same to the Class In-charge / Principal immediately after resuming college.
- 05. In case of Commerce & Arts students, the term shall not be deemed as kept and shall not be granted unless the student produces at the end of the term a certificate each from the head of the respective Department, stating that the students has completed the prescribed Tutorial course.
- 06. Students shall not attend the classes other than their own without the permission of the Principal.
- 07. Conduct of students in the classes as well as on the premises of the college shall be such as will cause no disturbance to the fellow students or to the other classes.
- 08. Students shall not loiter on the college premises while the classes are at work.
- 09. Smoking is strictly prohibited on the college premises.
- 10. Students shall do nothing either inside or outside the college that will in any way interfere with its orderly administration and discipline.
- 11. No society or association shall be formed in the College and no person will be invited to address a meeting without the Principal's prior permission.
- 12. No student shall collect any money as contribution for picnic, trip, and educational visits to some places, gettogether, study-notes, charity or any other activity without the sanction of the Principal.
- 13. The college does not arrange or organize picnics or pleasure trips.
- 14. In College debates and other meetings, the Chair shall be taken by a responsible person approved by the Principal and the subject of the debate shall have prior approvals of the Principal.
- 15. No student shall communicate any information to or write about matters dealing with the college administration to the press.
- 16. Students are expected to take proper care of the college property and help in keeping the college premises neat and tidy. Damage to the property of the College e.g. disfiguring walls, doors, fitting and breaking furniture etc. is a breach of discipline and will be duly punished.
- 17. The students should not leave their books, valuable and other belongings in their Class room / Gymkhana room / Ladies Common Room etc. whenever they move away from their rooms. The College is not responsible for any property lost.
- 18. Students requiring the Principal's signature on any kind of document, Certificate, Testimonials and Application



should first contact the Office Superintendent of the college. No papers should be brought by the students directly to the Principal for his signature.

- 19. If for any reason the continuance of a student in the college in the opinion of the Principal, shall be final, detrimental to the best interest of the College, the Principal may ask such student to leave the college without giving the reason for the decision.
- 20. Students joining the college are supported to accept and observe all the rules and regulations of the college and to undertake to submit to the normal enforcement of the same to the satisfaction of the Principal whose decision in this regard shall be final.
- 21. Vehicles (two-wheeler or four wheeler) brought by the student will be parked at the owner's risk, in the place provided for the purpose. The college is not responsible for any damage or theft of the vehicle.
- 22. Single use plastics are banned in College Campus.
- 23. Any form of ragging is strictly prohibited on the college campus. The students responsible for ragging activity are liable to face strict disciplinary action.

- c) To provide adequate basic understanding about the Banking, Insurance & other financial services among the students.
- d) To give an adequate exposure to operational environment in the field of Banking Insurance and other related financial services.
- e) To inculcate trained & practical approach among the student by using modern technologies in the field of Banking, Insurance etc.,

#### ELIGIBILITY

0.5209 A candidate for being eligible for admission to the Bachelor of Commerce (Banking & Insurance) Degree Course shall have passed XII<sup>th</sup> std. Examination of the Maharashtra State Board of Secondary & Higher Secondary Education, Pune or its equivalent and secured not less than 45% marks in aggregate at (40% in case of reserved category Candidates) at one and the same sitting. Every candidate admitted to the degree course in affiliated colleges conducting the course shall have to register enroll himseif/ herself with the university.

#### **R.4295** Duration of the course and related information:

#### **Evaluation System:**

#### Standard of Passing

The learner to pass a course shall have to obtain a minimum of 40% marks in Internal (20 out of 40 marks), External (24 out of 60 Marks) and practical 20 out of 50 Marks) examination separately to pass the course and minimum of Grade E in the project component. wherever applicable to pass a particular semester.

#### Internal Evaluation (40 Marks)

- 1. 30 Marks (any one of the following)
  - 1) Written Test or
  - b) SWAYAM (Advanced Course) of minimum 20 hours and certification exam competed or
  - c) NPTEL (Advanced Course) of minimum 20 hours and certification exam competed or
  - d) Valid International Certifications (Prometric, Pearson, Certiport, Coursera, Udemy and the like)
